
### Public Notice

**Subject: Opportunity for Outstanding Professionals (Retired/In-Service) to Apply for Mentorship in the National Mission for Mentoring (NMM).**

The National Council for Teacher Education (NCTE) is inviting applications from outstanding professionals desirous to join the national pool of mentors under NMM program as Mentors. This initiative offers a unique opportunity to contribute to the capacity building of school teachers in alignment with NEP 2020. As a Mentor, one will play a pivotal role in shaping the future of school teachers in their pursuit of continuous professional development.

2. **Roles and Responsibilities:** Selected Mentors will be responsible for providing expert guidance and support to school teachers (Mentees) in their respective domains. School teachers are the cornerstone of society, shaping future generations by imparting knowledge, values, and critical thinking skills. Their influence extends far beyond the classroom, building a foundation for responsible citizens and innovative leaders. By fostering collaboration, encouraging reflective practice, and offering constructive feedback, mentors empower teachers to excel, ultimately enhancing student learning outcomes.
3. **Unified Mentoring Interface (UMI):** The Mentor-Mentee interactions will be conducted online through the NMM Web portal. Mentors will be expected to engage regularly with their Mentees, providing ongoing support and guidance through virtual meetings, discussions, and resource sharing.
4. **Areas for Mentorship:** The areas in which mentorship is required for Mentees (school teachers) are given in *Annexure I* with the option to choose one or more areas of expertise.
5. **Eligibility Criteria:**
  - a) **Background:** Professionals and experts are sought from diverse backgrounds, including but not limited to sectors such as healthcare, engineering, law, education, armed forces, business, and the arts. This includes individuals such as professionals, entrepreneurs, community leaders, retirees, and others possessing valuable skills and expertise relevant to mentoring school teachers.
  - b) **Experience:** The required professional experience has been categorized based on the Area or Domain given in *Annexure-I* (as above).
6. **Proficiency in Language:** They must have effective communication skills.
7. **Professional Requirement:** Professional/ experts should have conducted workshops, attended seminars/webinars and conferences organized by institutions/ organizations.

8. **Application Process:** Interested professional/experts are required to fill the application form on the link as under:
